RECONFIRMATION MEETING FOR DECEMBER, 2020

Reconfirm instructional delivery method: (Overall statement)

Our district will be continuing with the current offerings for instruction through the end of 2020. We will continue to work with individual families who have requested for their students in Grades BK-6 to move from Aggie Tech Academy to in-person instruction and believe we will be able to accommodate these changes.

We have worked to improve the current schedule for students in Grades 7-12 to eliminate the conflicts that existed in the first semester. The only exceptions are students who are enrolled in seven classes or who had to repeat classes. We are also hoping to begin offering a more intentional in-person school day each week for students in Grades 7-12 beginning no earlier than January 13, 2021.

Reconfirm how instruction will be delivered for each grade level:

Elementary (Grades BK - 5): Offering in-person and online options for all students with Dansville teachers. Bringing more students back in person, per their requests.

Middle School (Grades 6 - 8): Offering in-person and online options for 6th grade students with Dansville teachers. Bringing more students back in person, per their requests.

For Grades 7 and 8, we are offering online courses with Dansville teachers as well as opportunities to come into the building for in-person small group instruction and support via Sign Up Genius. Offering Aggie Aid Tuesdays and Thursdays from 6-8 pm and Saturdays from 10 am – 2 pm.

We will roll out an improved schedule for second semester for students in Grades 7-8 to eliminate the conflicts that existed in the first semester. The only exceptions to this are students who are enrolled in seven classes in our six period day (we offered this option due to the synchronous/asynchronous choices students

had first semester) or students who had to repeat classes. We are also hoping to begin offering a more intentional in-person school day each week for students in Grades 7-8 beginning no earlier than January 13, 2021. More details need to be finalized prior to final rollout, but the idea is to bring kids in on Wednesdays with a model that will be tailored to different student needs. Additional information will be shared as it becomes available.

High School (Grades 9 - 12): For Grades 9-12, we are offering online courses with Dansville teachers as well as opportunities to come into the building for in-person small group instruction only if students meet the exception criteria in the most recent MDHHS order. We are also offering Aggie Aid Tuesdays and Thursdays from 6-8 pm and Saturdays from 10 am – noon only for students who meet the exception criteria. While this was paused for three weeks by order of MDHHS, this option was immediately reinstated on Wednesday, December 9th when it became available again.

We will roll out an improved schedule for second semester for students in Grades 9-12 to eliminate the conflicts that existed in the first semester. The only exceptions to this are students who are enrolled in seven classes in our six period day (we offered this option due to the synchronous/asynchronous choices students had first semester) or students who had to repeat classes. We are also hoping to begin offering a more intentional in-person school day each week for students in Grades 9-12 beginning no earlier than January 13, 2021. More details need to be finalized prior to final rollout, but the idea is to bring kids in on Wednesdays with a model that will be tailored to different student needs. Additional information will be shared as it becomes available.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

Our students who are in the elementary behavior intervention room have had in-person, full time schooling all year. This is also true for our students in Grades 6-12 who are in the Aggie Room, where they receive significant special education support. All other students with an IEP have been offered either in-person or online supports, in compliance with their IEP goals.

Several at-risk students in Grades 7-12 have also been offered the chance to work in the building. This offer has also been extended to students who are unable to secure reliable internet at home.

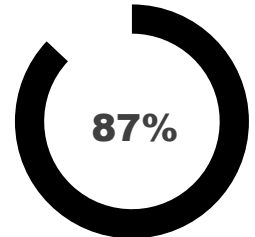
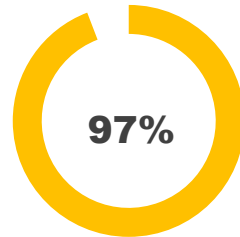
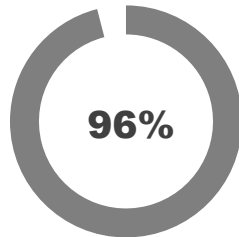
REVIEW WEEKLY 2-WAY INTERACTION RATES
