- Mrs. Jaime Ruckel thanked the board and the administration for their efforts in keeping students safe and shared her family's positive experiences with online learning.

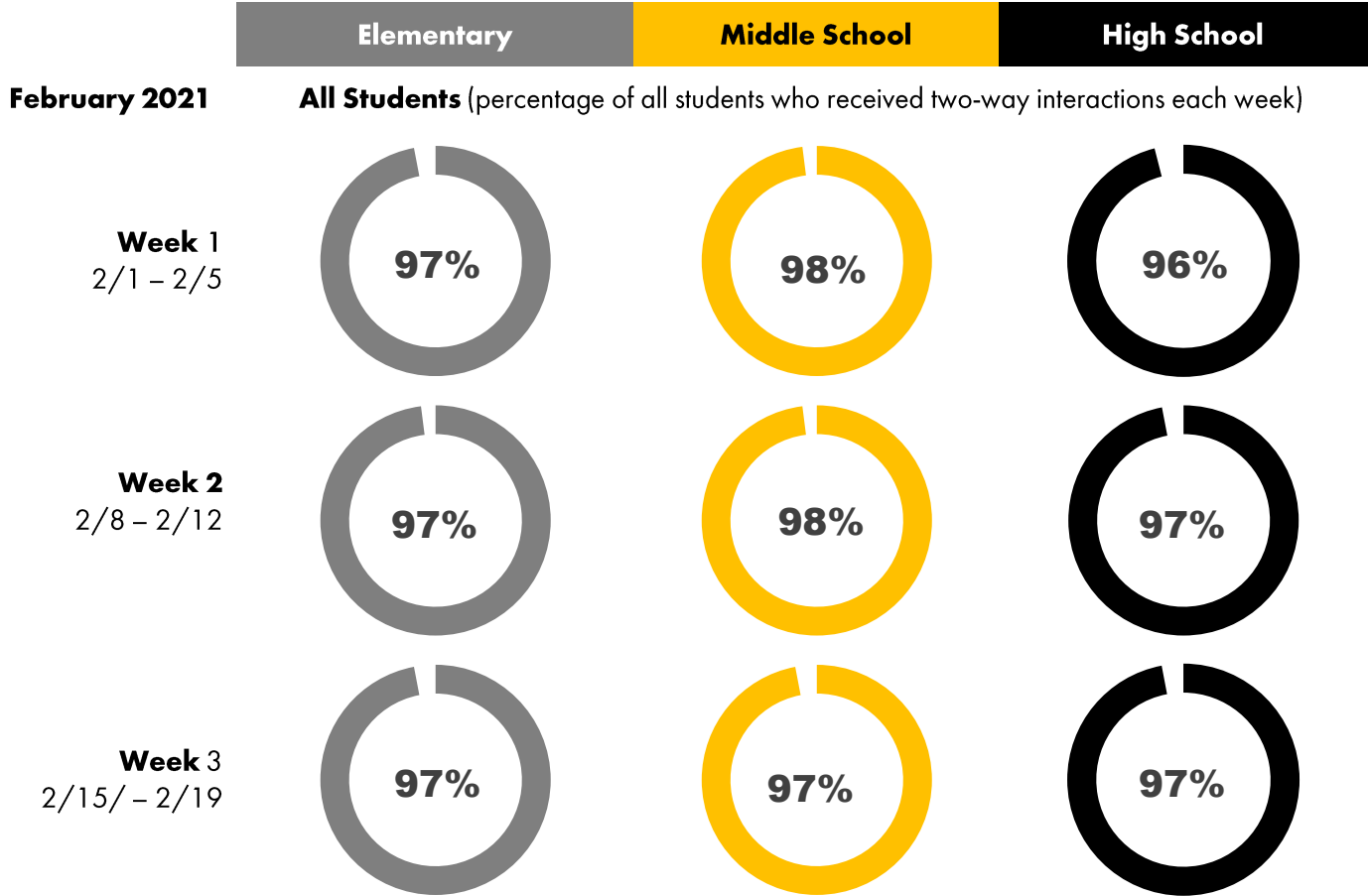
SPECIAL PRESENTATIONS
